

PUBLIC POLICY MAJOR REQUIREMENTS

<p>5 CORE COURSES For students to qualify to do their internship, they must have completed at least 3 of the following 6 required courses: STA 199L, PUBPOL 155D, PUBPOL 301, PUBPOL 302*, PUBPOL 303, PUBPOL 304. IMPORTANT:

- Major components: 12 Courses including Public Policy focused internship.
- There are no prerequisites needed to declare the Public Policy major. However, there is a flow to the requirements and advanced planning is key to completing the major on time.
- No Satisfactory/Unsatisfactory (S/U) courses may be counted towards the major requirements. UPDATE: Effective Fall 2023, PUBPOL 155D Introduction to Public Policy will be a satisfactory/unsatisfactory (S/U) course.
- No more than 2 transfer (including study abroad) credits may be counted towards the major requirements.
- Students are not permitted to take core courses, the history elective, or the 401-699 elective abroad.
- All PUBPOL students are required to meet with the PUBPOL administrative staff prior to registration for enrollment eligibility each semester.

PUBLIC POLICY INTERNSHIP & SATISFACTORY COMPLETION OF PUBPOL 120

Review the internship section of the [Undergraduate Handbook](#) for detailed information about the internship requirements.

For an internship to be approved to meet the PUBPOL internship requirement, students must demonstrate:

- 1) Day-to-day work requires student to engage in public policy, AND
- 2) Day-to-day work is analytical and project-oriented rather than clerical or direct service (such as tutoring or building a clinic).

Internships that WILL count:

- Any nonprofit or government organization (.org, .gov, .edu, or .mil).
- Duke Engage, Hart Leadership, Duke in DC, Stanback Internships, and Bass Connections.
- Required military service.
- Very limited private sector internships. Only those with a significant public policy focus. Examples include government relations teams, political campaigns, and political communication firms.

Internships that will NOT count:

- Internships in finance, business, or commercial consulting.

GENERAL REQUIREMENTS

- **PREREQUISITES:** 3 of the 6 required courses: STA 199L, PUBPOL 155D, PUBPOL 301, PUBPOL 302, PUBPOL 303, PUBPOL 304. At least one course needs to be PUBPOL 155, PUBPOL 301, or PUBPOL 302/GLHLTH 210. Majors must complete their sophomore year prior to internship.
- **TIME COMMITMENT**
- 350 Hours
- **TIMING:** Internship hours do not accrue until after declaring the PUBPOL major and completion of the prerequisites. Majors should complete the summer after their sophomore or junior year.
- **GEOGRAPHICAL LOCATION:** Domestic & International

- **REQUIRED INTERNSHIP DOCUMENTATION** (See details in box on right.)
- **FINANCIAL ASSISTANCE:** Available to majors who receive financial aid from Duke. Complete Sanford Internship Experience Form in Handshake once you have accepted an internship.

EXAMPLES OF ELIGIBLE INTERNSHIPS

- **PUBLIC POLICY INTERNSHIPS:** A wide variety of policy internships are listed in the Handshake internship database.
- **DUKE IN DC:** Spring semester study away program.
- **DUKEENGAGE:** All programs are eligible each summer.
- **HART LEADERSHIP:** Selected opportunities eligible each summer.
- **BASS CONNECTIONS –** Must be a two-semester program.
- **VERY LIMITED PRIVATE SECTOR INTERNSHIPS.** Only those with significant public policy focus. Examples include government relations teams, political campaigns & political communications firms.

INTERNSHIP DOCUMENTATION

- **HANDSHAKE EXPERIENCE RECORD:** Completed by the student and internship supervisor to describe proposed internship tasks and their relation to public policy. *DEADLINE: May 15th*
- **ENROLL IN PUBPOL 120 COURSE IN SUMMER SESSION 2:** Permission numbers will be distributed by Suzanne Pierce, Undergraduate Program Coordinator. *DEADLINE: June 30th*
- **SUPERVISOR EVALUATION:** Completed by the supervisor to evaluate the student’s performance; Sanford sends link to supervisor. *DEADLINE: August 1*
- **WRITTEN ASSIGNMENT:** Completed by the student to provide feedback to the Sanford School Internship Staff and information to future students. *DEADLINE: August 1*
- **SANFORD INTERNSHIP EXPERIENCE:** 1) Assessment and exploration of a specific policy issue impacting their organization, or 2) creating and analyzing a stakeholder map and assessment of the different players, or 3) a professional career exploration. *DEADLINE: August 1*
